

VOID WHERE PROHIBITED BY LAW.

1. **Eligibility:** The Free Preventive Care Video Visit Member Incentive is available to all Sanford Health Plan and Sanford Health Plan of Minnesota (collectively "Sanford Health Plan") Affordable Care Act ("ACA") individual and Medicare Advantage ("Align powered by Sanford Health Plan") members who complete a Preventive Care Video Visit on or before December 31, 2026. Individual must be an ACA or Align member of Sanford Health Plan in active status during plan year 2026; no other Sanford Health Plan Members or other persons are eligible. A \$50 Member incentive gift card/certificate redeemable at eligible grocery stores will be mailed to the Member within 60 days upon documented completion of a Free Preventive Care Video Visit prior to December 31st of 2026. Sanford Health Plan reserves the right to verify all documented evidence of the Member completion of the Preventive Care Video Visit and will only issue the gift card/certificate upon verification. Limit one gift card/certificate per eligible Member who completes the Preventive Care Video Visit per Plan year. This Member Incentive Giveaway (the "Giveaway") is subject to federal, state, and local laws and regulations and void where prohibited by law.
2. **Sponsorship:** The sponsor is Sanford Health Plan or Sanford Health Plan of Minnesota, as applicable, located at 4800 W. 57<sup>th</sup> St. Sioux Falls, SD 57108. Sponsor will manage and conduct this member incentive Giveaway as described in these Official Rules.
3. **Member Incentive Giveaway Period:** This promotion begins on January 1, 2026, for ACA individual and for Align powered by Sanford Health Plan members, at 8:00 am CT and ends on December 31, 2026, at 11:59 pm CT. To be eligible for this Giveaway, member must have completed the Free Preventive Care Video Visit within the specific promotional timeframe.
4. **Redemption Rules:** The \$50 gift cards/certificates are not redeemable for cash or other credit, are not transferable, may not be sold or resold, and are not legal tender. All purchases are subject to the store's usage and refund policies. Stores reserve the right to disqualify certain purchases and the gift card/certificate may not be compatible with other offers.
