<b>What is the overall deductible?</b>	For <u>network providers</u> <b>\$3,500</b> individual / <b>\$7,000</b> family For <u>out-of-network providers</u> <b>\$7,000</b> individual / <b>\$14,000</b> family <b>Copays do not apply to deductible.</b>	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. <b>Are there services covered before you meet your deductible?</b>	Yes. <u>Preventive care</u> services are covered before you meet your <u>deductible</u> . <b>What is not included in the out-of-pocket limit?</b>	<u>Premiums</u> , <u>balance-billing</u> charges (unless balanced billing is prohibited), and health care this <u>plan</u> doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .

### Does this plan provide Minimum Essential Coverage? Yes
